Unfortunately, Postal funding has been one of the sticking points preventing the bill from being passed. We must continue to push for new sources of revenue such as Postal banking. We should push for the elimination of dis-

counts for pre-sorting houses whose mail is still being run through our machines in order delivery point sequence. If we turn a blind eye to the milking of the postal cash cow, we will the ones who will be going thirsty.

The TPWU state convention is still scheduled for June 24 through June 26, 2021 in Houston, Texas. Hopefully, we will be able to congregate again by then. distribution of vaccines and vaccinations should be in place prior to then but if not, it could result in either a cancellation or virtual convention. We will keep the membership informed as to what will need to be done to proceed. Every day I am hearing of more members getting infected to the point that I dread answering the phone. Please do everything you can to protect yourselves and your families. Use your masks, wash your hands, and use hand sanitizer, social distance when you can, and avoid large crowds. 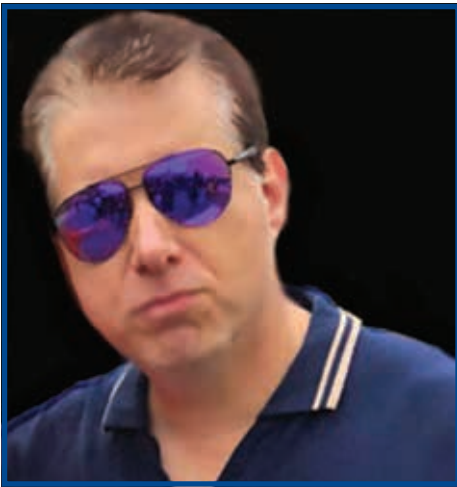
live your life as a living testimony of peace so others can see that there is hope.

Earlier this year, when management policies delayed the mail, we rallied

with a supportive public and helped compel management to commit to robust procedures for handling election mail. With extra hours, attention, effort and priority, postal workers moved “heaven and earth” to make sure ballots were processed, arrived on time and were counted. Every APWU local stepped up to ensure the timely delivery and processing of ballots with hundreds of our locals involved in local labor/management task forces to ensure



the job was done well and any problems were addressed. Since Election Day we have stood with the vast majority of people in this country who expect and insist that every vote, including all mail ballots, will be counted and the results respected. The APWU stands fully united with the entire labor movement and fair-minded people throughout the land against any attempts to subvert the will of the people, any march toward dictatorship and tyranny, with fabricated claims of a rigged election based on vote-by-mail.

As we look ahead, we recognize that great challenges will continue to face us, no matter who sits in the

White House. The Biden presidency creates a better and more supportive political environment. The rest is up to us, for movements move presidents and Congress, not the other way around. Louis DeJoy is still the Postmaster General and he promises to follow through on policies that slow down mail and drive away revenue now that the election is through. The Postal Board of Governors who are enabling these destructive policies remains in place for the foreseeable future. The struggle continues for needed COVID emergency financial relief from Congress. We must remain vigilant in the constant effort for maximum health and safety in this COVID world. Wall Street postal privatizers come in all political stripes. Efforts to expand and enhance Postal Services must accelerate. Postal reform legislation is needed. Bargaining for a new Union Contract begins this coming year.

LOOKING FORWARD

The 87th Texas Legislature won't gavel in until January, but state lawmakers on Monday November 9, 2020 got their first chance to file legislation for what's expected to be a particularly tough 140-day stretch at the Capitol next year. With fights over voter access and ballot integrity dominating the election offices and courthouse across the state in recent months, lawmakers are also seeking to resolve some of the central issues around how Texans vote with a battery of bills filed in the early hours Monday. Before noon, nearly 30 pieces of elections-related legislation had already been proposed in both chambers. Mail-in voting and voter registration emerged

as two key focal points in bills filed by members of both parties. There was also legislation focused on countywide voting centers, voter identification and access for voters with disabilities, straight-ticket voting and designating any day an election is held statewide, including primaries, as a state holiday. The Legislative Director of the National Letter Carriers Association and I plan on being in Austin to talk to as many State Senators and Legislative Representatives as we can

to push vote-by-mail Legislation. I also will be writing, email and try to meet with our senate and congressional representatives to continue to push for Postal Reform Legislation

I want to wish everyone a Safe and Happy Holiday Season. The Christmas mail rush will be beginning soon, and this will be a busiest time of year for us. Remember safety First your goal is to go home to your family at the end of your tour.

CALL CONGRESS: Save the Postal Service, Reverse Mail Delays, and Pass \$25 Billion in Emergency Pandemic Relief

The COVID-19 pandemic is threatening the United States Postal Service. A sharp decline in revenue means the Post Office could run out of money, threatening the essential service postal workers proudly provide the country.

The new Postmaster General, Louis DeJoy, has instituted harmful policies causing serious delays of mail. These cuts undermine the public's confidence – currently 91% of the public approve of USPS – in the Postal Service and drive away business.

In order to #SaveThePostOffice, we need everyone to demand their member of Congress:

- ✓ Pass \$25 billion in emergency COVID funding for the USPS.
- ✓ Permanently reverse delays.

Let's keep up the massive wave of support for our public Postal Service. Postal workers are absolutely dedicated to providing prompt reliable and efficient postal services to the country through the pandemic, through the election and beyond. 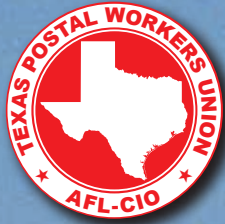

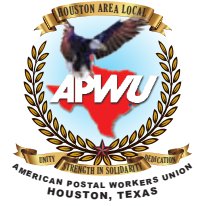

5. Make additional copies of your blank Credential Form, should your local send more than 10 Delegates.

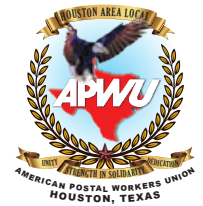
6. Indicate if the Delegate is Deaf/Hard of Hearing.

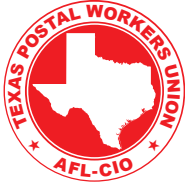
